- B. iCEV Digital Content for CTE programs for 2023-24 academic year Renewal of our current agreement to provide digital content services (online curriculum resources) from iCEV not to exceed \$13,006.00 for the 2023-24 academic year. The local districts will use the digital content as supplementary curriculum for CTE programs in AgScience, Construction, Family and Consumer Science, Business, Marketing and Finance.

This fee includes 10 teacher seats and 338 student seats for Corunna Public Schools, Durand Area Schools, Laingsburg Community Schools, New Lothrop Area Public Schools, and Perry Public Schools. The Shiawassee RESD will be reimbursed for the digital content services by our local districts based on their usage of the services.

C. imagine learning LLC – Digital Content Services (Online Curriculum Resources) for 2023-24 Academic Year

Renewal of our current agreement to provide digital content services (online curriculum resources) from imagine learning LLC not to exceed \$87,000.00 for the 2023-24 academic year. The local districts will use the system for credit recovery, intervention programs, and online learning.

This fee includes 80 concurrent seats for \$48,000.00 shared by the eight public school districts and the Shiawassee RESD. In addition, Corunna Public Schools and Owosso Public Schools have each purchased 50 single use seats for \$15,000.00 per district, and Perry Public Schools purchased 20 single use seats for \$9,000.00.

SRESD will be reimbursed for the digital content services and training by our local districts based on their usage of the services.

To help offset the cost to each district, the Administration is also recommending the Shiawassee RESD contribute \$150.00 per building. The remaining amount will be billed to each district via the annual bill packet that is distributed in the spring. Total amount subsidized by Shiawassee RESD for this licensing is \$3,450.00.

It is anticipated the instructor would be 0.34 FTE in Spring 2023-24 and up to 0.67 FTE for the 2024-25 academic year, depending on enrollment.

The CTE Culinary Instructor's compensation would follow the Shiawassee RESD professional salary schedule. This position would be funded through CTE program tuition paid by the local districts and the SRESD CTE millage revenue.
