- A. Leave of Absence Scott Breece, Instructional Aide, effective October 13, 2023; return date to be determined.
- B. Leave of Absence Cassandra Stiles, CTE Facilitator, effective approximately January 31, 2024 with an anticipated duration of approximately six (6) weeks. To ensure consistent services for CTE students and programming, Tricia Walters will assume some of the CTE Facilitator responsibilities during Ms. Stiles' leave. Estimated cost for extra duties is \$12,900.00 and will be funded by the 61i grant received by Shiawassee RESD for the 2023-24 academic year.
- C. Position Change Elizabeth Findlay, Continuous Improvement & Multi-Tiered System of Support (MTSS) Director, with an annual salary of \$91,000.00 beginning November 8, 2023; funding for the position comes from MTSS grant, MDE Regional Assistance Grant, Special Education, and General Fund.
- D. Hire Hailey Sackett, Speech and Language Pathologist, with an annual salary of \$51,727.00 (Step 1/MA+ 30 of SIEA Contract). Start date is on or about October 23, 2023; funding for this position comes from Special Education.
- E. Hire Brittany Wiggins, Enrollment Specialist, with an annual salary of \$44,601.60. Start date is November 1, 2023; funding for the position comes from CTE millage revenue and 61b grants.

- A. Advanced Audiology, LLC contract with Advanced Audiology, LLC to provide audiological and consultation services for hearing impaired programs and our hearing impaired students beginning July 1, 2023 to June 30, 2024 at a rate of \$60.00 per hour and not to exceed 444 hours for the academic year ending June 30, 2024. Currently, Linda Wright is assigned to Shiawassee RESD for this position.
- B. Birch Agency contract with Birch Agency to provide school nursing services commencing August 24, 2023 through May 24, 2024. The rate of pay is \$65.00 per hour and not to exceed 40 hours per week. Currently, Autumn Wright, RN, is assigned to Shiawassee RESD for this position.
- C. Shiawassee RESD LEAs Mathematics Support contract with Michele Bruckman to provide math coaching, professional learning, and support for the Shiawassee County districts (LEAs) located in Shiawassee RESD. The contract will be for the 2023-24 academic year at the rate of \$37.50 per hour and will not exceed \$25,000.00; contract will be paid using Small, Rural School Achievement (SRSA) grant funding.
- D. Great Start Family Liaison Erica Matteson contract with Erica Matteson to provide services in the position of Great Start Family Liaison, effective on or about November 1, 2023 with an hourly rate of \$20.00 for up to 20 hours per week (not to exceed \$20,800.00); funding for this position is fully funded by the 32p State Aid Grant.
- E. Teacher Consultant Services to Non-Public Schools and Homebound Students contract with Betty Melrose to provide teacher consultant services for non-public schools and homebound students within Shiawassee County. The contract began July 1, 2023 and will continue through June 15, 2024 at a rate of \$40.00 per hour and is not to exceed 30 hours per week.
- F. MiSTEM Regional Youth Advisory Council Coordinator Chelsee Schram contract with Chelsee Schram to serve as the MiSTEM Regional Youth Advisory Council Coordinator within the five (5) county region (Shiawassee, Clinton, Eaton, Ingham, and Ionia). The contract began October 1, 2023 and will continue through June 30, 2024 at a rate of \$50.00 per hour for up to 15 hours per month not to exceed \$6,750.00.

- G. Certified Nursing Assistant (CNA) Health Science II Program Clinical Site Agreement Pleasant View Shiawassee County Medical Facility; contract with Pleasant View to serve as the clinical site for the Health Sciences Academy CNA training program for the 2023-24 academic year. Students must complete 24.5 clinical hours at a long-term care facility; Pleasant View has agreed to host the clinicals again this year. Students will be under the supervision of our CTE Health Science Academy instructors, Karah Jarman and Renae Wellman.
- H. Shiawassee County Child Care Tri-Share Program Agreement Shiawassee Economic Development Partnership (SEDP) –contract with SEDP for the purpose of continuing the Tri-Share Child Care program. Shiawassee RESD will continue as the grant fiduciary and program administrator. SEDP will continue responsibility for the recruitment of participating employers and employees. Additionally, SEDP will continue responsibility for the initial intake of participating employees and will confirm and document program eligibility. SRESD will provide \$5,000.00 annually to SEDP for additional program administration and recruitment activities associated with participation of Shiawassee County employers and employees in the Tri-Share Program for each Tri-Share grant period; this period will begin January 1, 2024. The \$5,000.00 is funded from the Tri-Share grant from Michigan Department of Labor and Economic Opportunity.
- I. School Social Work Intern for 2023-24 Academic Year approval is granted to pay a stipend of \$10,000.00 for the below-listed individual:
 - Macie Casaday (supervised by Janis Woods/Tracy Hyde)
 Funding for this internship stipend will come from the 31n Grant.

This position will also assist with compilation of outcomes and performance related to school safety plans, school safety trainings, school safety products, and other school safety measures.
